Dear Parent or Guardian:

The Florida Department of Education offers the opportunity for all students in Grades 11 and 12 to earn a passing concordant score using the newly adopted Classical Learning Test (CLT). The CLT provides students an opportunity to earn both an Algebra 1 and/or an English Language Arts Grade 10 assessment concordant score, which would meet their graduation requirement.

The CLT will be administered through The School District of Lee County on **October 16, 2024**, at Oasis High School. There is no charge for your student to participate in the assessment.

We **encourage** you to review content that your student will be exposed to. The CLT is broken into three sections: Verbal Reasoning, Grammar and Writing, and Quantitative Reasoning. Students must participate in all three sections to receive a score. The total standard testing time for this assessment is 2 hours and scores are released within 8 days.

The reading passages associated with this assessment may expose your student to topics such as religion, philosophy, science, literature, and historical/American founding documents. Because of the nature of the passages, we recommend that you take the time to review some of the content that is shared in the practice assessments and information from the Classical Learning Test website (<https://www.cltexam.com/>). Additional resources are listed on the back of this letter.

The CLT administration is a College Reportable score and can be used for college entrance. Students with approved accommodations (through CLT) will be provided those accommodations for this assessment. Please reach out to your child's school Test Coordinator with any follow-up questions.

Your child is not obligated to take the CLT. **If you want your student to take the Classical Learning Test, please sign and return this form to Mrs. Long by August 30, 2024.**
